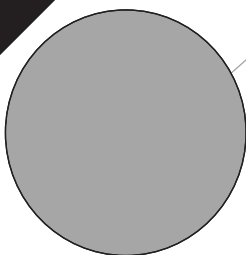

THIS IS YOUR TAX RECEIPT

ALL ITEMS DONATED TO THE NATIONAL KIDNEY FOUNDATION OF FLORIDA (NKFF) ARE DEDUCTIBLE FOR INCOME TAX PURPOSES AT THEIR PRESENT MARKET VALUE.
